The Society for the Advancement of Criminology, American affiliate of the International Criminological Society, was founded some ten years ago for the following purposes: 1) to promote the study of criminology and its related studies in American colleges and universities; 2) to stimulate research in criminology; 3) to professionalize the preliminary training of young men and women entering the fields of law enforcement, probation and parole, prison administration, and other occupations directly or indirectly connected with the phenomena of crime; and 4) to provide advanced in-service training at the adult-education and post-graduate levels for carcerists in criminological fields. The Society provides an information service for foreign criminologists, assists in the placement of personnel, and advises on the publication of articles and monographs. The Society publishes a Directory of Criminological Studies, a monthly news-letter, and distributes occasional brochures, reports, and other items of interest to its members. Its official journal is *The Journal of Criminal Law, Criminology and Police Science* (published at Northwestern University Law School).
