The American Society of Criminology, affiliate of the International Criminology Society, was founded for the following purposes: 1)to promote the study of criminology in American universities; 2)to stimulate research in criminology; 3)to professionalize the training of young persons entering the fields of law enforcement, probation and parole, prisons, and allied occupations; and 4)to provide advanced in-service training at the adult-education and post-graduate levels for careerists in criminology. The Society provides an information service for foreign criminologists, assists in the placement of personnel, and advises on the publication of articles and monographs. The Society publishes a Directory of Criminological Studies, a monthly newsletter, and distributes brochures, reports, and other items of interest to its members. Its official journal is *The Journal of Criminal Law, Criminology and Police Science* (published at Northwestern University Law School).

K6—ASSOCIATION FOR THE PSYCHIATRIC TREATMENT OF OFFENDERS

The Association for the Psychiatric Treatment of Offenders was founded six years ago to carry on in the United States the work pioneered by the Institute for the Scientific Treatment of Delinquency in London. The Association is incorporated under the laws of the State of New York as a non-profit, philanthropic corporation for the following purposes: 1)to provide non-institutional psychotherapy, individual or group, for offenders referred by the courts of the state; 2)to refer persons with psychoses or psychoneuroses likely to result in criminal conduct to a panel of cooperating psychiatrists and psychologists; 3)to provide training seminars in modern psychological-psychiatric techniques and theories for police, correction officers, probation and parole personnel, court officers, and others whose work brings them in frequent contact with offenders; 4)to stimulate and finance psycho-criminological research; 5)to organize and administer programs of public education in the understanding of the offender and his problems; and 6)to cooperate with other agencies, public and private, with similar objectives. The Association provides speakers for lay and professional meetings, places articles in appropriate publications, conducts a placement service for professionals interested in working with delinquents, makes arrangements for observation and experimentation involving delinquents, and maintains a library of representative foreign and domestic materials, published and unpublished, for the use of scholars in this field. The association publishes a news-letter and distributes to its members and to cooperating groups bibliographies, research reports, book reviews, and other items of interest.

NEW YORK INSTITUTE OF CRIMINOLOGY

The NEW YORK INSTITUTE OF CRIMINOLOGY was founded in 1947 by a committee headed by the late New York City Police Commissioner James S. Bolan for the professional and scientific training of police officers and investigators. During the past ten years more than one thousand students have been graduated including a large contingent of police officers from foreign countries. The Institute faculty and staff, now numbering twenty-two, also engage in criminological and police science research, are frequently retained by police agencies as consultants, and are available to private organizations as speakers on appropriate topics.
