

Associate/Full Professor-Criminal Justice Chair 109500

The University of West Florida Department of Criminology and Criminal Justice in Pensacola, Florida, invites applications and nominations for the full-time position of **Associate/Full Professor (Criminal Justice Chair) 109500**. The Department Chair position is a renewable 12-month contract.

Located in the College of Education and Professional Studies, the Department of Criminology and Criminal Justice offers a B.A. in Criminal Justice, a dual B.A. in Criminal Justice and Social Work, a B.A. in Interdisciplinary Social Sciences Children and Society, and a M.S. in Criminal Justice. Courses are offered face-to-face at the Emerald Coast and Pensacola campuses and online.

Minimum Qualifications for Position: Qualified applicants must meet criteria for the rank of Associate or Full Professor at the time of appointment. A Ph.D. in Criminal Justice or Criminology or in a closely related discipline with documented specialization in Criminal Justice or Criminology from an accredited institution with a demonstrated record of achievement in teaching, academic research, and service is required.

The primary responsibilities of the Chair include providing administrative leadership, including scheduling, assessment, recruitment and retention, management of departmental budgets, mentoring and support of faculty, staff, and students, and leadership in implementing college and university initiatives. The candidate will also teach face-to-face and fully online undergraduate- and graduate-level courses in Criminology and Criminal Justice and be expected to maintain an active research agenda, contributing to the national dialogue on important issues in the candidate's field of study, and provide service to the department, college, university, and community. The successful candidate will engage in active student mentoring, and participate on Doctoral level comprehensive examination and dissertation committees.

This position requires a commitment to collegiality, academic citizenship, shared governance, high-impact educational practices, scholarship and creative activity, professional development, and community engagement. The ideal candidate will have academic leadership experience. Evidence of a commitment to diversity is expected. Start date is July 15, 2019 with consideration of an earlier start date contingent on candidate availability. Salary is commensurate with experience. The preferred response date for applications is November 26, 2018. Review of applications will begin on November 27, 2018, and will continue until the position is filled.
