QUALIFICATIONS

Required:

- Ph.D. in criminal justice, criminology, or closely related field. A law degree (JD) only is not appropriate for this position.
- Must meet the required qualifications and provide evidence of an active research/publication record that is commensurate with departmental requirements for this rank.
- The successful candidate agrees to serve as department chair for a three year term (with a one course reduction per semester).
- Strong commitment to teaching
- Teaching experience at a college/university level
- Required areas of teaching are open
- Experience with a variety of teaching methods and/or curricular perspectives
- Experience interacting with a diverse and multicultural population
- Must be eligible to work in the United States

Preferred:

- Preferred areas of expertise are corrections, law & society, law & social change, social justice, criminal procedure, and criminal law.
- Excellent communication skills
- Interest in teaching a diverse student population

ESSENTIAL DUTIES AND RESPONSIBILITIES

- Primary responsibilities include: teaching, scholarly research, advising students majoring in Criminal Justice, and participating in departmental/campus/community/professional service.
- The incumbent will have a teaching load of 18 credits per academic year in the core courses of the Criminal Justice major and minor, and in upper division electives. The candidate is expected to establish and maintain an active research program involving undergraduate students.
